FY 2024-2025 Regional Solid Waste Grant Program Alamo Area Council of Governments Notice to Private Industry Providing Recycling or Solid Waste Services

This notice is issued by Alamo Area Council of Governments (AACOG) to advise private industries providing recycling or solid waste services within the 13-county AACOG region that AACOG is accepting applications from local governments seeking grant funding for recycling and other solid waste management projects. These funds are provided through a grant from the Texas Commission on Environmental Quality (TCEQ), under the authority of Section 361.014, Texas Health & Safety Code.

In accordance with the statutory provisions, a project or service funded under this program must promote cooperation between public and private entities and may not be otherwise readily available or create a competitive advantage over a private industry that provides recycling or solid waste services.

In order to comply with these requirements, applicants with projects that will provide recycling or other solid waste services are asked to notify private industries providing similar services within the geographic service area of the project, to ensure that any questions about the proposed project can be addressed early in the application process. This notification process is not required for projects where a recycling or solid waste service will not be provided. If you are contacted by a local government about a proposed project, we recommend you respond in writing as soon as possible with any concerns you may have about the project.

In addition to this coordination process by the local governments, the applications, which were due at AACOG on Friday, October 27, 2023 at 10:00 a.m., will be available for public review during the time period and at the location listed below. A summary listing of all submitted applications will be posted at www.aacog.com on November 1, 2023.
